

Subject- Relieving of 5 JTOs working in T&D circle for Karnataka circle regarding.

Kindly refer to letter no. HRD-II /4-12/ Genl. Corr. /2017/34 dated at Bangalore 16.08.2019 % CGMT Karnataka circle (letter attached) regarding relieving of JTOs presently working in T&D circle for Karnataka circle. In connection with, it is submitted that 5 JTOs recruited by Karnataka circle was allotted to T&D circle during fresh appointment. As per rules, these JTOs are in the strength of T&D circle being initially appointed in the said circle by Karnataka circle. Now Karnataka circle illegally repatriating them to Karnataka circle ignoring the crucial demand of T&D circle which is unjustified so it is requested that these 5 JTOs which are in the strength of T&D circle may be restrained in their working circle and the claim of Karnataka circle with drawing them back with the consideration that they are on deputation is null and void. The case of illegal withdrawal may be taken at corporate office for cancellation of orders already issued by BSNL CO ND letter no. 5-21/2019-Estt-IV/Repatriation/33 dated 6.08.2019.
